Re: Charge letter for Audit, Compliance, Ethics and Risk Oversight Committee (ACER)

Thank you for your service on the UC Santa Cruz Audit, Compliance, Ethics and Risk Oversight Committee (ACER). This committee coordinates a range of compliance and accountability efforts on our campus and brings clarity and a comprehensive approach to our compliance, ethics, and risk management. As a combined audit and risk intelligence committee, this group has oversight of both the annual audit plan and our risk intelligence cycle.

Purpose

The UC Santa Cruz Audit, Compliance, Ethics and Risk Oversight Committee (ACER) assists Audit and Management Advisory Services by helping to ensure that its objectives and goals support those of UCSC and the University of California.

ACER Composition and Chair

ACER Oversight is chaired by the UC Santa Cruz Chief Ethics and Compliance Officer (CECO) and includes the UC system Chief Compliance and Audit Officer (CCAO) and Director of Audit and Management Advisory Services as ex officio members. A member of the chancellor's office provides staff support for the committee, including preparation of meeting agendas and coordinating meeting schedules.

Meeting Frequency

ACER Oversight meets quarterly (or no less frequently than three times a year) and at least two weeks after ACER Workgroup meetings.

Role in the Development of the Annual Audit Plan

ACER Oversight participates in and reviews activities related to the development of the Annual Audit Plan, including risk identification and assessment. ACER Oversight reviews the proposed Annual Audit Plan and recommends its approval prior to its submission to the Chancellor who forwards the plan to the CCAO for consolidation into the systemwide Annual Audit Plan. Any changes to the Annual Audit Plan that result in approved audits being dropped from the current year's plan, even if it only involves the audit's deferral into a subsequent year, require the approval of ACER Oversight and the CCAO.

Scope of Responsibilities

For ACER Oversight to assist Audit and Management Advisory Services in carrying out its mission and maintaining its objectivity and independence, ACER Oversight's purview includes:

- A summary of progress against the Annual Audit Plan
- Proposed changes to the approved Annual Audit Plan
- Personnel changes and their impact on the completion of the Annual Audit Plan
- Current project-specific summaries of significant reports issued and their observations
- Major investigation activities and their impact on the program of regular audits
- Identification and assessment of emerging risks for consideration in future audit plans
- Proposal and identification of new and ongoing risk mitigation measures
- Summary of external activities and significant issues identified
- Open recommendations and/or management corrective actions from previously issued audit reports, especially for situations where senior management awareness could lead to more rapid action or the removal of barriers to action to improve controls
- On an annual basis, review of the proposed Annual Plan and an annual summary report of the activities conducted by the Internal Audit function during the year.
